Introduction

The general budget of the state of Kuwait reflects the approved plan for the financial year 2025/2026. The budget of Ministries and Government department includes all revenues estimated to be collected, in addition to the estimated public expenditure incurred over the current fiscal year. It monitors political, social and economic events and its implications on the public finances.

The Ministry of Finance - The Public Budget Affairs has prepared the budget for government ministries and departments for the fiscal year 2025/2026 in accordance with the financial, social and economic policies of the country.

The main features of the annual budget 2025/2026:

- 1- The budget of the fiscal year 2025/2026 applying according to the guide and classified budget (Cash Basis) which is issued by Law no. (4) for the year 2015, according to the concept and definition of the internationally agreed by the GFS Guide for the year 2001 issued by the International Monetary Fund. Also, the budget for the Fiscal year 2025/2026 was prepared according to the provision of the circular No. (3) for the year 2024 on the preparation of the ministries, government departments, attached authorities and the bases and rules to be followed in preparing them according to the budget (Cash Basis).
- 2- According to the principle of realism, oil revenues have been estimated according to the barrel price of 68 \$ / barrel, and the volume of production is 2.500 million / barrel per day.

3- Directing ministries, government agencies, attached authorities and independent institutions to study and prepare the revenue and expenditures estimation in accordance with the state public policy, regarding rationalization of spending, reducing and controlling expenses, eliminating unnecessary and secondary expenses that do not affect the performance of government agencies and working in accordance with laws, decrees and decisions issued up to date.

The Ministry of Finance hopes to achieve the desired political, social and economic objectives to improve and raise citizen's living standards, and working to fulfil the state of Kuwait into a financial and commercial centre to attract local and foreign investments.

Decree Law No. (14) for Fiscal Year 2025 on Budget Appropriation for Ministries and Government Departments

Decree Law No (14) For the Year 2025 Concerning Budget Appropriation Of Ministries and Government Departments For The Fiscal Year 2025/2026

- After reviewing the Constitution,
- And upon the Amiri order issued on 2 of Dhu Al Qidah 1445, corresponding to May 10 of 2024,
- The Decree Law No (106) for the year 1976 concerning the Future Generations Reserve Fund which modified by Law No (18) for the year 2020,
- The Decree Law No (31) for the year 1978 regarding the rules for preparing public budgets and the oversight of their implementation, the final accounts, and the amended laws related to it.
- And based on Decree No (84) for year 2024 regarding ministerial deputations and substitutions, and its amending decree.
- Based on the proposal of the Minister of Finance
- Upon the approval of the Council of Ministers, the following decree was issued:

Clause (1)

The revenues of the Ministries and Government Departments' Budget for the fiscal year 2025/2026 are estimated as 18,231,486,000 KD (Eighteen billion, two hundred thirty-one million, four hundred eighty-six thousand Kuwaiti Dinars only), which covers what is stated in Table (A) attached to this Decree Law.

Clause (2)

The Expenditures of the Ministries and Government Departments' budget for the fiscal year 2025/2026 are estimated at 24,538,000,000 KD (Twenty-four billion, five hundred thirty-eight million Kuwaiti Dinars only), distributed on the Chapters listed in the Table (B) attached to this Decree law.

Clause (3)

Expenditures are estimated to exceed revenues 6,306,514,000 KD (Six billion, three hundred six million, five hundred fourteen thousand Kuwaiti Dinars only).

Clause (4)

The Prime Minister and the ministers, each within their jurisdiction, shall implement this Decree Law, which will be published in the official gazette and come into effect as of April 1, 2025.







Glossary

Guidance 1 - Revenues:

The revenues of ministries and government departments come from various sources from which the state obtains financial resources to meet public needs. Among the most of these sources is oil, which is considered the primary source of revenue for the state, followed by other revenue, then taxes and fees. The revenues are composed of six chapters highlighted below:

1.Oil revenues:

Revenues collected by the Ministry of Oil from the Kuwait Petroleum Corporation for the marketing of crude oil and its derivatives, both domestically and internationally.

2. Non-Oil revenues:

Revenues from taxes and fees (Chapter 2), social contributions (Chapter 3), grants (Chapter 4), other revenue (Chapter 5), and asset disposal and other non-operating revenue (Chapter 6).

Guidance 2 - Current expenditure:

Regular and recurring expenditures necessary for the daily operations of government entities. These do not include capital expenditures or new investment expenses. The current expenses are divided into eight chapters:

21.Compensation of employees:

Covers all types of employee compensation, including salaries, bonuses, and other financial benefits for government employees in return for the work they perform during a relevant period.

22.Goods and Services:

Expenditures for goods and services that government entities require to sustain their daily operations. It includes the cost of purchasing goods, maintenance, and other necessary services.

24.Cost of finance:

Payments that government entities are obligated to make for certain types of liabilities, such as deposits, securities (excluding stocks), loans, and accounts payable. These payments arise when a government entity borrows from external parties. The cost of financing is the expense incurred by the government entity (the debtor) for using the principal debt, which represents the economic value provided by the creditor. Financing costs (such as interest) are incurred continuously throughout the period the liabilities exist. The rate at which financing costs are incurred may be recorded as a percentage of the outstanding principal debt for each period, as a predetermined fixed amount, as a variable amount based on a specific index, or as a combination of these methods.

25. Subsidies:

Financial contributions provided by the government without requiring any return. These subsidies are offered to producers or suppliers based on their production levels or to cover specific types of expenditures. They may also be granted to public corporations or specific social sectors to compensate for losses they incur on their production activities. Subsidies are classified by the type of recipient (public or private) and the type of enterprise (financial or non-financial).

26. Grants:

Financial contributions provided by the government for specific purposes, either domestically or internationally. These may include financial support for non-profit organizations or for specific public services. Grants are classified by the type of entity (public or private) and the type of grant (current or capital).

27. Social benefits:

Cash or in-kind transfers designed to protect society as a whole or specific societal group from certain social risks. A social risk is defined an event or circumstance

that could negatively impact the well-being of affected households, either by imposing additional burdens on their resources or by reducing their income. Examples of social benefits include the provision of medical services, unemployment compensation, and social security pensions.

28. Other Expenditures and Remittances:

Other types of expenses and transfers that do not fall under the previous chapters, such as natural resource rents, losses from currency exchange differences, and various other financial obligations.

Guidance 3 - Capital expenditures:

Expenses paid for the purchase, acquisition, or major maintenance of fixed assets. Maintenance is considered major if it extends the asset's productive life or improves its efficiency and performance. Government entities use assets to provide goods and services for their operations, similar to companies. For instance, administrative buildings and office equipment are used to provide social or individual services such as general administrative services. Additionally, governments often own assets that the general public directly consumes or that must be preserved due to their historical or cultural significance. Therefore, when applying the concept of assets to the general government sector, it typically encompasses a much broader range of assets than those typically owned by the private sector.

32.The purchase of non-current assets:

Tangible fixed assets that are used repeatedly or continuously in production processes for more than a year. The defining characteristic of a fixed asset is not its physical durability, but its ability to be used repeatedly or continuously in production over an extended period. For example, some goods, such as coal used as fuel, may be highly durable in physical terms but are not considered fixed assets because they can only be used once.
